Communist social credit score

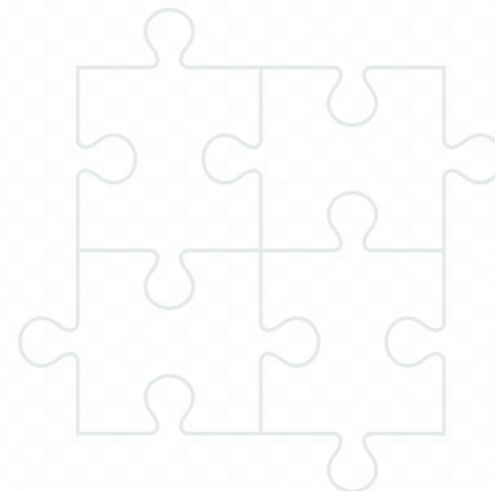

The mortality rates per 100,000 are the lowest among the **unvaccinated** population in every single age group in England, an official report published by the UK Government confirms.

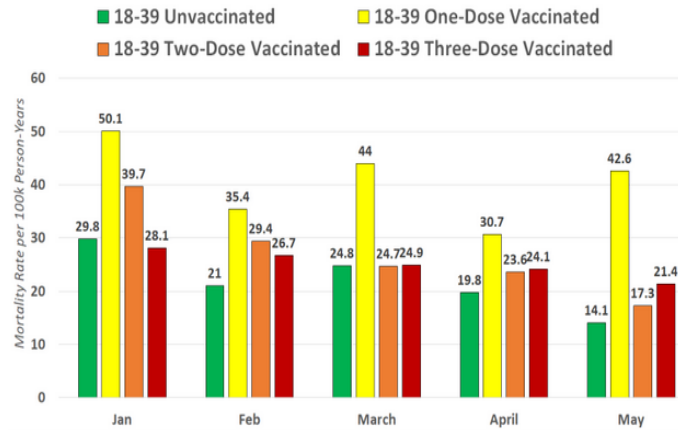

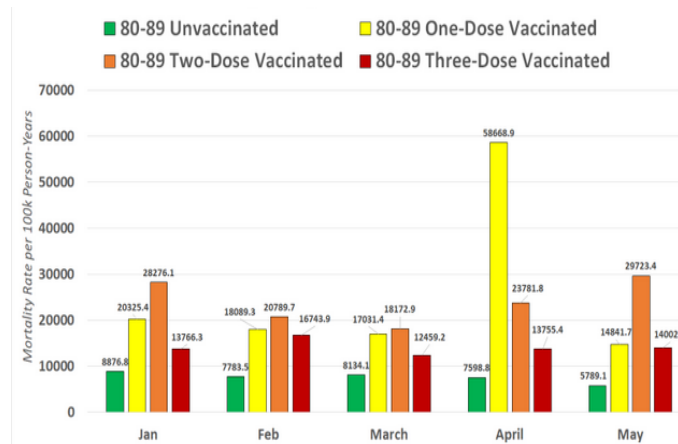

The following chart shows the monthly age-standardised mortality rates by vaccination status among 18 to 39-year-olds for Non-Covid-19 deaths in England between January and May 2022 :



In every month since the beginning of 2022, partly vaccinated and double vaccinated 18-39-year-olds were more likely to die than the unvaccinated. For the triple-vaccinated, after an initial marginal benefit death rates progressively worsened over the following 4 months, with a 52% higher death rate.

The following chart shows the monthly age-standardised mortality rates by vaccination status among 80 to 89-year-olds for Non-Covid-19 deaths in England between January and May 2022 :



Unlike the 18—39 year-olds, the vaccinated 80 to 89-year-olds are more likely to die than the unvaccinated at any time after being vaccinated. In April 2022 (four months after the booster rollout, they were 213% more likely.

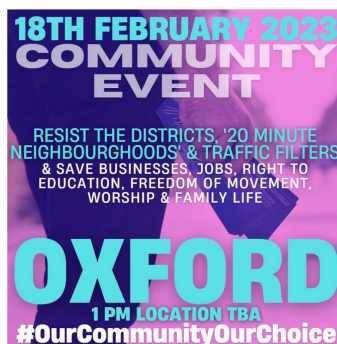
In fact it is to deprive people of their ability to travel, effectively locking them to a large degree within digital “cells”, fining them if they go outside.

For example, Canterbury, UK, proposes to split the city into five zones, with camera surveillance on the borders. If you try to drive your car across zone borders you will be fined: According to Page 14 of the draft [Canterbury District Local Plan to 2045](#) – there will be “Implementation of an ANPR-based sectoring system and modal filters to limit cross-city trips.”

In London, surveillance technology is expanding to control our car trips. London’s ULEZ zones will be expanded to cover most, if not all, of the city. This means you will have to pay £12.50 a day for the privilege of getting into your car, no matter how short or long the trip is. There will be a [200 million pound ANPR camera network](#) to fine drivers when they do.

Oxfordshire County Council, is proposing to install traffic filters as a trial on six roads in Oxford., currently planned to begin in 2024.

“The traffic filters are not physical barriers of any kind and will not be physical road closures. They are simply traffic cameras that can read number plates. If a vehicle passes through the filter at certain times of the day, the camera will read the number plate and (if you do not have an exemption or a residents’ permit) you will receive a fine in the post.”



Wellington Regional Council is already proposing new suburbs be “non-vehicle-dependent”, and high blocks of flats in the Hutt Valley have insufficient parking for private vehicles, which then congest the streets.

First, you never isolate healthy people. You only isolate people showing symptoms. The scam of asymptomatic transmission was at the core of this public con.

We have 30 years of research showing masks do not prevent the spread of coronaviruses. This was confirmed by the high quality Danish mask study published in November 2020.

As Ashley Bloomfield acknowledged, masks don't protect anyone (in spite of the propaganda advertising "I protect you. You protect me"); they just remind us of the risk of COVID (i.e. keep people in fear—a standard psychological torture technique. They also:

- Showed the Government how many people would obey an irrational diktat,
- Created a cult of virtue-signalling amongst wearers, believing they were "good citizens" protecting everyone while non-mask-wearers were demonised as "enemies of society".

This latter led to another means of dividing society against itself.

We knew early on that COVID-19 was a mild disease, comparable to the seasonal flu. (Infection Fatality Ratio of 0.15% compared with 0.1%). It also mainly affected the elderly or health-compromised.

The cruise ship Diamond Princess demonstrated how mild COVID-19 was—over 2000 passengers, mostly elderly (i.e. in the target age group) and over 1000 crew. All would have been exposed. There were 699 cases and 13 deaths, (with, no necessarily from, COVID) with no primary treatment care identified. Survival rate was 99.7%.

Ivermectin and Hydroxychloroquine were known to be safe and effective against viral infections (reference?)

A number of countries used a basic primary care "COVID-19 kit", including Ivermectin, as did some doctors "below the radar". They all had great success in lowering hospitalisation and death.

A Spanish hospital pilot study found Vitamin D3 was 100% effective in eliminating deaths. A Thai study found a simple 0.9% saline nasal spray reduced hospitalisations by 95%.

Historic pandemic analysis demonstrated that the "pandemic" was on its way out before vaccines were administered. And beginning mass vaccination during a pandemic just causes "viral escape" or mutation—exactly what we saw!

The efficacy figure provided by Pfizer (95%) was shown to be a misrepresentation of the data. (The New South Wales COVID Report for week ending 30 July 2022 showed all 164 deaths were vaccinated.)

Children were specifically not at risk from COVID-19 and are poor spreaders. In fact pandemics traditionally end with a pool of children with naturally-acquired herd immunity.

Natural immunity is known to always be superior to vaccine-based immunity, so there was never any justification for imposing mandates

Did you know that “correctly prescribed” medical treatment is the third leading cause of death in our society (after heart disease and cancer). And if we consider medicine suppresses the cures for these, it is actually all-up the leading cause of death in our society.

In general, Western medicine was designed to keep people sick and dependent on drugs that suppress symptoms—an income source for life. The drugs often have side-effects, which require more drugs to suppress. The perfect money-making machine.

Meanwhile, any effective cure is attacked as quackery.

For example, doctors are only allowed to prescribe surgery, radiation, or chemo for cancer. Yet effective treatments and preventions are well known.

For example Apricot kernels contain a selective cytotoxin—a type of substance that billions of research dollars have been spent to develop a patentable pharmaceutical. But the sale of Apricot kernels has been banned by the Govt. on the false claim they are toxic. In fact common table salt is about nine time more toxic than Apricot Kernels.

Then there is a class of substance called acetogenins, found in high levels in pawpaw twig. This used to be considered the only class of substance that could kill Multiple Drug Resistant (MDR) cancer cells. (DMSO and Chlorine Dioxide Solution might also be able to do this).

When tumours are shrunk with chemo treatment about 2% of the tumour remains—MDR cells. A new tumour grows that is entirely MDR cancer cells. Chemo is useless against these and the patient dies.

In 1994 a 12 year study of chemo patients was published (J. Clinical Oncology), finding that chemo was only effective in 3%. Yes, that's right. In 97% of patients chemo didn't help. "Would you like to donate to cancer?" asks the collector.

Every dollar donated "to cancer" is literally donated to perpetuating cancer, not finding a cure.

There are many cures already known. According to a 1969 lecture reported by Dr Richard Day, the Rockefeller Institute already knew many cures for cancer back then.

But cancer was to be a key means of achieving the globalists' depopulation agenda.

So what cures are there for cancer?

Dr Royal Rife (1888—1971) developed a frequency-based means of targeting cancer for destruction. In 1934, Dr Rife was given a number of human test subjects from the Pasadena County Hospital, all of whom had terminal cancer. They had been essentially left to die because no more could be done for them by the cancer industry.

Dr Rife treated them under the supervision of a Special Medical Research Committee of pathologists and oncologists from the University of Southern California (USC).

It was their job to expertly document the progress of the patients over a 90-day period during treatment. 86.5% of the patients were completely cancer free. Another 13.5% received an adjusted treatment for an additional 30 days and then they also became 100% cancer-free.

Amygdalin, found predominantly in apricot kernels, is a selective cytotoxin for cancer cells. It breaks up to form cyanide and benzaldehyde inside a cancer cell, but not in a healthy cell (due to the different enzymes present). Years ago NZ researchers announced they had developed a patentable selective cytotoxin. What happened to it?

Apricot kernels are so successful in curing cancer they have been banned from sale, claiming they contain cyanide and are toxic. In fact common table salt is about 9 times more toxic than apricot kernels.

Tumours typically contain about 2% Multiple Drug Resistant (MDR) cancer cells. Chemo treatment can kill only the other 98%. These then grow to make an untreatable fully-MDR cell tumour. Acetogenins used to be considered the only substance that could kill MDR cancer cells. They are found in highest levels in Pawpaw twigs (the powder is commercially available).

Essiac (Caisse Tea) was developed by nurse Rene Caisse in Canada in the 1920s, based on a native Indian herbal formula. The tea cured hundreds of "terminal" patients in the 1920s and '30s. They had all been diagnosed by medical doctors, sometimes multiple doctors. She tried to get her treatment legalised. However she was met every step of the way with resistance from high ranking officials within the government and medical associations.

CFR is financed in part by the Gates,⁹ Rockefeller, Ford and Carnegie foundations,¹⁰ and has influenced U.S. foreign policy ever since its inception 95 years ago. Almost all U.S. secretaries of defense have been lifetime members, as have most CIA directors. This is of crucial importance, considering the CFR's goal, from the start, has been to bring about a totalitarian one world government, a New World Order (NWO) with global top-down rule.

[The CFR's goal is] submergence of U.S. sovereignty and national independence into an all-powerful one-world government ... This lust to surrender the sovereignty and independence of the United States is pervasive throughout most of its membership ... In the entire CFR lexicon, there is no term of revulsion carrying a meaning so deep as 'America First.' ~ CFR member Admiral Chester Ward, 1975
In 1950, the son of one of the CFR's founders, James Warburg, said to the Senate Foreign Relations Committee: "We shall have world government whether or not you like it — by conquest or consent."¹¹

Similarly, in 1975 CFR insider Admiral Chester Ward wrote that the goal of the CFR was "submergence of U.S. sovereignty and national independence into an all-powerful one-world government."¹²

According to Ward, the desire to "surrender the sovereignty and independence of the United States is pervasive throughout most of its membership," and "In the entire CFR lexicon, there is no term of revulsion carrying a meaning so deep as 'America First.'"

With Ward's last comment in mind, published in 1975, it's interesting to contemplate who has opposed President Trump's America First agenda, and why. Many Americans, even if they don't like or support Trump personally, agree that taking care of America and Americans' interests first is a rational decision for any leadership, and they've been hard-pressed to rationalize how an anti-America First policy can be good for the nation.

Well, Ward gives us the answer. Those who oppose America First policies do so because they're working on behalf of a network that seeks to eliminate nationalism in favour of a one-world government.

Originally, all NZ MPs were independents. Then the Liberal Party was formed in 1891. The Labour Party was formed in 1916. The National Party was subsequently formed in 1936 from a coalition that had governed from 1931.

We originally had a bicameral system like the UK. The Upper House (Legislative Council) was abolished in 1951. The Select Committee process was meant to ensure some level of control over the single house. At the same time we were supposed to review the First-past-the post electoral system. But that didn't happen until 1993.

The Select Committee process has become a farce as far as a democratic protection is concerned.

Consultation on Bills is often held over Christmas and or a short timeframe, limiting public input. Committees can demonstrate a clear agenda. Trying to prevent the public from making important submissions. They often ignore input completely in making recommendations. For example 95% of public submissions on the Bill transferring the decision on water fluoridation away from elected local councils were against the Bill. But the Bill went through unchanged as it was policy.

Supplementary Order papers also make a mockery of the Select Committee process. These should only be used to address technical issues will Bills or inconsistencies. But they have been used to make substantial policy changes., such as expanding significantly the range of firearms confiscated by the Government following the Christchurch mosque shootings. SOPs go through after the Select Committee process, so there is no check on the ruling party's power, unlike the bicameral system.

But at a more concerning level our Governments are not responsive to the people, but are dictated to by international organisations. Outwardly this can be done by signing up to international treaties or agreements, such as giving total control to the WHO to decide when there is a pandemic and how we should respond to it. This is a private organisation with highly dubious influencers.

Covertly, governments have policy dictated by a relatively small group of globalists who have their own agenda. (See Topic number 8) So it doesn't really matter which party is in power—they have big policy issues dictated and any public consultation is just a sham.

This is becoming increasingly obvious, and is the push behind Agenda 21, Agenda 2030, and the WEF's "Great Reset" (just a conspiracy theory according to Deputy PM Grant Robinson in spite of being openly stated on the WEF website.

- It would remove control of the oil industry
- It would release the world from paying a handful of ultra-rich families for that oil
- It has military applications
- It would make totalitarian world Government much more difficult.

Solar and wind power are intermittent. You need massive battery storage to supply on-demand power. They are also environmentally disastrous if you look at whole-of-life-cycle.

Tesla completed the commercialisation of Alternating Current (AC) electricity. His financial backer, J P Morgan, owned the General Electric Company that had produce Direct Current electricity, which suffers massive transmission losses. Morgan made a fortune out of General Electric once it switched to AC. He and his associates also made fortunes from their copper mines, as massive amounts of copper wire was needed.

In developing AC, Tesla noticed another energy form that sat “behind” electrical energy. This concept was also noted by James Clark Maxwell, the founder of modern electromagnetics.

The energy source was drawn from the Earth’s electromagnetic field. It can be transmitted through the Earth or the air, and the user tunes into it like tuning into a radio station.

Tesla converted a Pontiac and drove it at speeds of up to 90 mph to prove it.

“The Trusted News Initiative”

In July 2019 the UK and Canadian governments hosted the *FCO Global Conference on Media Freedom*, where then BBC Director-General Tony Hall announced:

“Last month I convened, behind closed doors, a Trusted News Summit at the BBC, which brought together global tech platforms and publishers. The goal was to arrive at a practical set of actions we can take together, right now, to tackle the rise of misinformation and bias....I’m determined that we use that [BBC] unique reach and trusted voice to lead the way – to create a global alliance for integrity in news. We’re ready to do even more to help promote freedom and democracy worldwide.”

The initial Trusted News partners in attendance were the European Broadcasting Union (EBU), Facebook, *Financial Times*, First Draft, Google, *The Hindu*, and *The Wall Street Journal*.

Two weeks after WHO announced the Covid-19 pandemic on March 11, 2020, Canada’s CBC reported that the Trusted News Initiative had announced plans “to tackle harmful coronavirus disinformation.”

The TNI next agreed to engage with a new verification technology called Project Origin, led by a coalition of the BBC, CBC/Radio-Canada, Microsoft and *The New York Times* – with a mandate to identify non-authorized news stories for suppression.

Although we use the words “money” and “currency” interchangeably, they are not the same.

Money has traditionally been coins made of precious metal (Gold, Silver or Copper) and the value of the metal was the value of the coin (after allowing for “seniorage” - a deduction for the cost of minting the coin).

Today, currency might have the same face value but is not backed by anything real. We don’t even have gold reserves equal to the face value of currency notes and coins. Its accepted value is based on the confidence those who receive payment in it that the economy is strong enough that the Government can in future levy taxes to ensure payment of debt.

The advent of this approach derives from gold merchants of the past, and led to “fractional reserve banking”. That is, promissory notes (effectively bank notes now) were issued to several times the value of the gold held in the merchant’s vault because only a proportion of the metal was ever demanded at any one time. The borrower then had to acquire real money to pay “back” the “loan” from the merchant. If this sounds like a giant Ponzi scheme, it is!

And this is largely the way our banking system works today. In fact mortgages are scams in exactly this way.

When you apply for a loan the only criteria are your ability to earn income to meet “repayments” and your equity in the asset (so it can be sold if you default on payment). The money you believe you are borrowing is in fact created against your credit. It is not the bank’s money, or depositors’ money the bank is holding. It cannot lend that to you. Once the loan is approved the bank puts the “money” in a trust account and pretends it is theirs. You then sign (unnecessary and therefore fraudulent) mortgage documents that gives the bank the power to instruct your lawyer. You then commit to paying “back” to the bank money that was always yours, plus interest for something created out of thin air.

In fact our governments are scammed the same way by international banks, run by the Rothschild dynasty. They banks issue currency as debt (out of thin air) and charge “interest” on it. But the “interest” doesn’t exist unless it is issued as new debt. 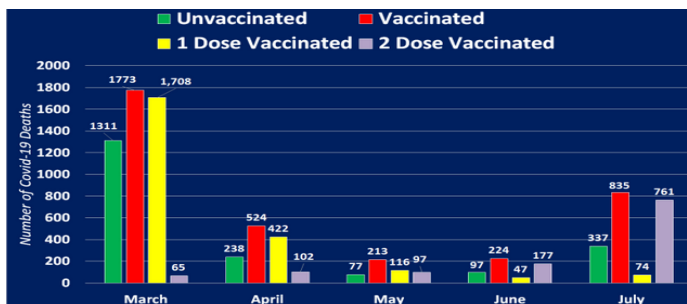

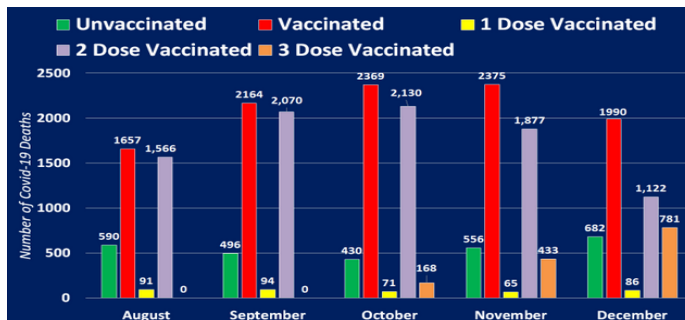

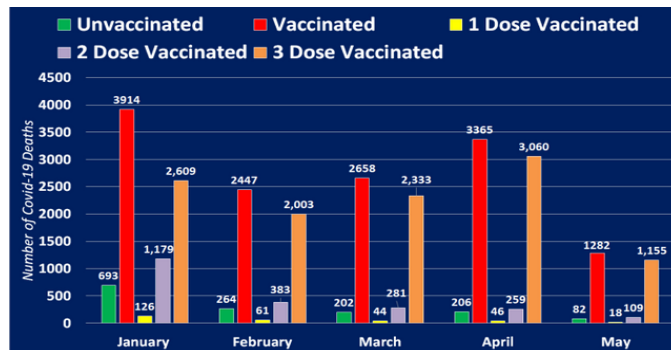

1956—Nelson and David Rockefeller establish The Special Studies project, managed by Henry Kissinger.
